ABC is a membership-driven, non-profit trade association focused on the construction industry. In this position, I drove ABC's brand identity, voice, and value, through storytelling and re-branding strategies.

- Promoted membership value through newsletters, social media, print marketing and grassroots strategies, contributing to a consistent 92% member retention rate placing our chapter in the top five in the country.
- Maintained a 27-30% open rate of weekly emails by segmenting audiences, shortening story length, and creating relevant content focused on advocacy and member events. Of 70 chapters nationwide, ours won the Excellence Award for outstanding event communication campaigns in 2017.
- Managed chapter brand re-fresh and determined, after the research process, that we must communicate our founding philosophies differently in order to match Washington demographics. This resulted in new member growth for the chapter.
- Developed strong social media presence, resulting in a 35% increase in Twitter followers over two years. I also worked directly with the chapter president on LinkedIn strategies, increasing engagement by leveraging her large base of connections.
- Surveyed members on how they learned about our events in order to determine which
  communications channels work best. This led to a reduction in cost and time spent developing inhouse print collateral, while also increasing engagement via email campaigns.
